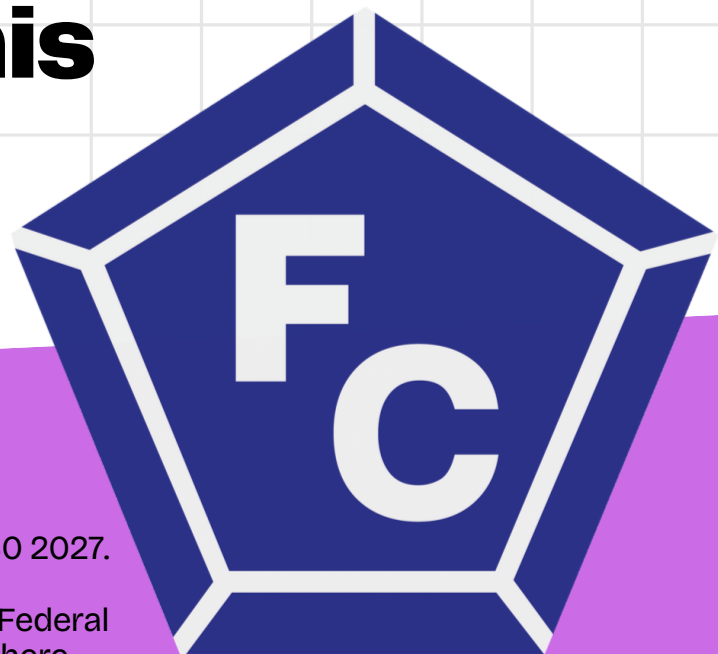

This scholarship program was intentionally designed to serve members at all stages of life and learning. We recognize that education doesn't look the same for everyone, and this program is our way of acknowledging the many paths to success and supporting those who are working hard to better themselves and their futures.

Please use this application to apply for one of the following scholarship categories:

- **College/University Scholarship (6 Available)**
 - For FCFFCU members who are high school or homeschool seniors during the 2026–2027 school year and plan to enroll in a two or four-year college or university.
- **Trade School Scholarship (2 Available)**
 - For FCFFCU members who are high school or homeschool seniors during the 2026–2027 school year and plan to enroll in a licensed trade, vocational, or technical program.
- **Adult Learner Scholarship (1 Available)**
 - For FCFFCU members age 18 and older returning to or beginning a college or university program.
- **GED Pathway Scholarship (1 Available)**
 - For FCFFCU members age 18 and older who have earned a GED within the past two years and are continuing their education.

Note: All applicants must be current members of First Choice Financial Federal Credit Union in good standing at the time of application to be eligible for consideration. Each member may apply for only one scholarship category per year. Multiple submissions will not be accepted. All applications must be postmarked on or before January 30, 2027.

Scholarship recipients are expected to attend the Annual Meeting on Friday, April 23, 2027, to receive their scholarship award. If a recipient is unable to attend the Annual Meeting, they must contact First Choice Financial Federal Credit Union in advance to make alternative arrangements. Scholarship awards must be picked up within five (5) business days following the Annual Meeting. If the scholarship is not picked up or alternative arrangements have not been made within this five-business-day period, the recipient will be considered to have declined the scholarship, and the scholarship may be awarded to an alternate recipient.

Application Process

Please complete the scholarship application in full, including a typed essay (in PDF or Word format), a copy of your extracurricular and community service resume (in PDF or Word format), two letters of recommendation, an official high school transcript or GED diploma (if applicable), and a letter of acceptance or proof of enrollment. Applications completed in pencil will not be accepted. Only complete submissions will be considered.

A sealed copy of your transcript must be submitted with your application. Open or unsealed transcripts will not be accepted.

All applications must be postmarked on or before January 30, 2027.

Selection Process

All completed applications will be reviewed by the FCFFCU Scholarship Committee through a blind review process, where all identifying information is removed to ensure fairness and impartiality.

Each application is evaluated using a standardized rubric based on:

- Academic Performance – GPA and overall achievement
- Essay Response – Clarity, originality, and relevance
- Community Involvement – Volunteer work and extracurricular activities

If you are selected, you will be contacted by letter and phone by March 1, 2027, to confirm your attendance at FCFFCU's Annual Meeting on Friday, April 23, 2027, where the scholarship awards will be presented. If your application is not selected, you will receive a notification letter by the same date.

If a scholarship recipient does not attend the Annual Meeting and does not contact First Choice Financial Federal Credit Union or make arrangements to receive the scholarship within **5 business days** following the Annual Meeting, the recipient will be considered to have declined the scholarship, and the scholarship may be awarded to an alternate recipient.

- **College/University Scholarship:** FCFFCU Members who are High School or Home School Seniors
 - Submit a resume outlining activities and involvement from grades 9 through 12, including school clubs, sports, volunteer work, religious or community organizations, and part-time jobs (if applicable).
- **Trade School Scholarship:** FCFFCU Members who are High School or Home School Seniors
 - Submit a resume highlighting activities from grades 9 through 12, especially hands-on experience, volunteer work, relevant courses, technical clubs, or part-time jobs that align with your chosen trade.
- **Adult Learner Scholarship:** FCFFCU Members Ages 18 & Up
 - Provide a resume detailing your employment history over the past two years, along with any recent volunteer work, community involvement, club participation, religious or civic organization involvement, or continuing education efforts.
- **GED Pathway Scholarship:** FCFFCU Members Ages 18 & Up
 - Submit a resume that includes your employment history (if applicable), as well as any volunteer experience, club or organizational involvement, religious/community service, or continuing education activities within the past two years.

Note: Employment is not required to be eligible for any scholarship. Applications without paid work experience will still be fully considered based on other areas of involvement.
